Purpose: To establish guidelines relative to persons not active members with Fire

District 8 riding with field crews.

References: N/A

Procedure:

- 1. Persons who are not active members with Fire District 8 may ride with field crews and are subject to the following provisions:
 - a) Riders must be authorized to ride by the on-duty 820 officer and must sign a waiver form. If arrangements are made in advance, the on-duty 820 will be notified by the Station on the day the rider is approved to ride. The waiver form is valid for one shift (or event) unless other approved arrangements have been made. The form will be forwarded to Administration for retention. Riders will be noted in the District's scheduling software program. The original document will be forwarded to the District Office for recording.
 - b) Persons under the age of 18 may ride with the approval of the Assistant Chief and receipt of a waiver signed by the rider and their legal guardian.
 - c) Only one rider at a time may be allowed on any one unit except when approved by the Assistant Chief (i.e. reporter and photographer).
 - d) Riders will be well groomed and in compliance with the dress code of their particular agency (when appropriate). No less than long pants, collared shirt, and closed toed shoes will be allowed.
 - e) The Station Officer will advise the rider of his/her role on the unit.
 - f) Crew members are responsible for the actions and safety of their rider. At no time will the crew knowingly put their rider in danger.
 - g) Riders are permitted to observe only. They are not to have contact with patients other than to observe and at no time are they to operate any District equipment or vehicles.
 - h) All riders will be scheduled through the Scheduling Officer..
