A Motion was made by Commissioner Rorie and seconded by Commissioner Hesse: **Move to offer the position of Fire Chief of Spokane County Fire Protection District No. 8 to Lonnie Rash**. The Motion carried unanimously.

In accepting the position, Chief Rash said he is excited and humbled to continue the legacy Chief Nielsen has established and he looked forward to preserving the District's family atmosphere.

Chief Rash received congratulations on his appointment. Commissioner Boling noted the Board chooses the Fire Chief and Assistant Fire Chief with a succession plan in mind.

Commissioner Hesse asked Chief Rash to bring his thoughts relative to an employment contract to the next regular Board of Fire Commissioners meeting.

B. Assistant Fire Chief Position: The commissioners asked Chief Rash to begin the process of recruiting an Assistant Fire Chief and return to the Board with his recommendation.
